Scope of practice

A medical massage therapist works closely with doctors to treat patients who are affected by pain, illness, or injury. Their typical day-to-day roles and responsibilities include:

- Providing massages to patients for a variety of lengths
- Using various massage techniques to manipulate muscles and soft tissue to treat chronic pain and injuries.
- Listening and explaining various aspects of medical massage to patients
- Massage soft body tissues to relieve discomfort and provide treatment for injuries, wellness maintenance or medical conditions.
- Apply pressure to specific parts of the body with the hands and fingers to release muscle tension and bring relief from related symptoms.
- Discuss client concerns, medical histories and specific stresses or pains to develop the most effective approach to massage treatment.
- Develop personalized treatment plans for individual clients that specify massage types, treatment areas and treatment frequency. Consult with psychologists, physicians and other healthcare professionals for help with treatment plan development.
- Refer clients to other professionals and therapists when appropriate and necessary to treat additional symptoms.

The work of the LMT has the specific goal; to alleviate pain and treat health conditions such as neuropathy, chronic pain, fibromyalgia, sports injuries, or even high blood pressure, just to name a few.

The work of a medical licensed massage therapist differs from that of a general massage therapist. Medical massage therapists have advanced training and/or experience that allows them to provide care focused on healing injuries, improving function, or increasing circulation. The LMT will typically receive referrals and orders from a physician as to the type of massage treatment they should give their patients.
